Coc Application

Annual Federal Funding stream- the largest in the US \$28,752,759 awarded to SCC CoC Individuals grant applications priority listing- review and rank to establish how it's prioritized CoC application asks 28-30 questions about how we perform as a community and as a system.

A high score means a better chance of getting funding 200 highest score 186.5 median score 150.5 SCC CoC score 156.6 8 or 9 point drop in the overall median score Along with an anticipated 18 point drop in SCC HUD has been placing more and more emphasis on Sys PMs and HIC and less emphasis on the the narrative. SCC score debrief reduction estimates: PIT= -24 SPMs= -10.5 HMIS bed coverage= -2 CoC coordination and Engagement unspecified -5 -43.5 total Loss between 22-26 points for PIT- about 10 of these points were loss bc of Sys PM. HMIS bed coverage if a certain amount are not included: PSH is not at 100% at this point out of all of the beds that we say are on the HIC, how many are participating in HMIS? How is our system performing in relation to money? Does the funding have a 1:1 relationship with the scoring? HUD uses the CoC application tier 2 application and ranked list compared to other CoCs **Review Systemwide Performance Measures and Benchmarks.** Desired Outcome: recap the performance measures and benchmarks that were set earlier this year. HUD and Local system performance measures Can we select a handful to say that we want to focus on these with the community? If the goal is to move the needle on some of these benchmarks. Show a mock up of the benchmarks - see each program on how everyone is been. Review this in context of public facing dashboards. FEMA and COVID19 Project Monitoring Desired outcome: Review data collection for FEMA and COVID19 projects. Discuss resources for reporting and monitoring. 1300 clients served so far. What we can learn about the clients who were there ? Focus on outcomes about clients who contract Covid 19 after staying in hotels. Are these emergency facilities actually keeping people safe?

Is this measurement based on certain funding sources? The county has over 100 veterans placed in

hotels from ssvf: a service type under ssvf this is collected in HMIS.
