#### **INTIMATE PARTNER ABUSE STATISTICS**

Approximately 2-4 million women are physically assaulted by their partner per year in the US (not counting verbal/mental abuse)

Attacks by male partners are #1 cause of injury to women between the ages of 15-44 (US Surgeon General)

1 of 3 women will be a victim of violence by husband or boyfriend at some point in her life (American Medical Association)





#### **STATISTICS**

• Nearly 1 in 4 adult women and approximately 1 in 7 adult men report having experienced severe physical violence from an intimate partner in their lifetime.

- 10% of women and 2% of men report having been stalked by an intimate partner.
- IPV alone affects more than 12 million people each year.



## WHAT IS INTIMATE PARTNER ABUSE?

#### **DEFINITION:**

A PATTERN OF ABUSIVE
BEHAVIORS EXERTED BY ONE
INDIVIDUAL IN ORDER TO
CONTROL OR EXERCISE POWER
OVER HIS/HER PARTNER IN
THE CONTEXT OF AN
INTIMATE RELATIONSHIP.

#### TACTICS:

- PHYSICAL
- EMOTIONAL
- Psychological
- VERBAL
- SEXUAL
- FINANCIAL
- SOLATION



#### EXAMPLES OF ABUSIVE BEHAVIOR

• PHYSICAL ABUSE: HITTING, BEATING, STRANGLING, PUSHING, SHOVING, SLAPPING, KICKING, PULLING HAIR, PINCHING, BITING, BEING HELD AGAINST YOUR WILL, HAVING OBJECTS THROWN AT YOU

• **SEXUAL ABUSE:** ANY TYPE OF FORCED SEXUAL ACTIVITY, FROM RAPE TO UNWELCOME TOUCHING



#### EXAMPLES OF ABUSIVE BEHAVIOR

- **EMOTIONAL ABUSE:** Name Calling, insulting YOU, DEGRADING REMARKS, HUMILIATING YOU IN ANY WAY, MAKING YOU FEEL GUILTY, PLAYING HEAD GAMES, CRAZY-MAKING
- OR PREVENTING YOU FROM LEAVING, NOT LETTING YOU CONTACT FRIENDS OR FAMILY, NOT ALLOWING ACCESS TO THE TELEPHONE OR VEHICLE



#### EXAMPLES OF ABUSIVE BEHAVIOR

- THREATS/INTIMIDATION: THREATENING TO HURT YOU, THE CHILDREN, YOUR FAMILY OR PETS, DAMAGING YOUR PROPERTY WHEN THEY'RE ANGRY (THROWING OBJECTS, PUNCHING WALLS, KICKING DOORS)
- OUSING CHILDREN: THREATENING TO TAKE THE CHILDREN AWAY, MAKING ACCUSATIONS OF BEING A BAD OR UNFIT PARENT, THREATENING TO HARM CHILDREN IF YOU DON'T AGREE, USING THE CHILD'S FEELINGS AS A WAY OF CONTROL, MAKING A CHILD TAKE SIDES IN AN ARGUMENT

#### WHY DON'T VICTIMS JUST LEAVE?

THERE ARE PLENTY OF REASONS WHY SOMEONE WOULD NOT LEAVE AN ABUSIVE RELATIONSHIP. SOME OF THEM INCLUDE

- FEAR
- OBELIEVE THE ABUSE IS NORMAL
- LOVE
- CONCERN FOR THE CHILDREN
- Lack of Financial Resources



#### WHY DON'T PEOPLE JUST LEAVE?


- PRESSURE FROM FAMILY AND FRIENDS




#### IMMIGRANT POWER AND CONTROL WHEEL






# Gay, Lesbian, Bisexual and Trans Power and Control Wheel





# WHAT MAKES A HEALTHY RELATIONSHIP?





#### How can I offer support?

- REMIND THEM THAT THEY DO NOT DESERVE TO BE ABUSED AND THE ABUSE IS NOT THEIR FAULT.
- BE AVAILABLE TO LISTEN IF SOMEONE ASKS FOR HELP. REMEMBER THAT IT MAY BE DIFFICULT FOR THEM TO SHARE THEIR EXPERIENCE.
- ENCOURAGE THE PERSON TO CONTACT A DOMESTIC VIOLENCE AGENCY, WHERE THEY CAN RECEIVE FREE, CONFIDENTIAL AND JUDGEMENT FREE HELP.



### HOW CAN SOMEONE STAY SAFE?

SOMETIMES PEOPLE DECIDE TO STAY WITH THEIR ABUSIVE PARTNER. SOME STEPS THAT PEOPLE CAN TAKE TO STAY SAFE INCLUDE...

- O DEVELOP A SAFETY PLAN
- BE PREPARED TO DIAL 911 AND TEACH YOUR CHILDREN HOW TO AS WELL.





# SEXUAL ASSAULT

Every 2 minutes, another American is sexually assaulted.

Each year, there are about 237,868 victims of sexual assault.



#### SEXUAL ASSAULT

#### TOUCHING

- Rape
- Child Molestation; Lewd and Lascivious Acts
- Sodomy
- Forced Oral Sex

## NON-TOUCHING

#### **DEFINITION OF SEXUAL ASSAULT**

- SEXUAL ASSAULT IS ANY TYPE OF SEXUAL ACTIVITY (TOUCHING OR NON-TOUCHING) THAT A PERSON DOES NOT AGREE (I.E., GIVE CONSENT) TO.
  - SUCH AS INAPPROPRIATE TOUCHING, FORCED EXPOSURE TO PORNOGRAPHY, VOYEURISM, STALKING, SEXUAL HARASSMENT
- RAPE IS WHEN A PERSON COMMITS AN ACT OF SEXUAL PENETRATION WHEN THE ACT IS ACCOMPLISHED AGAINST THE VICTIM'S WILL BY MEANS OF FORCE, VIOLENCE, DURESS, MENACE, OR FEAR OF IMMEDIATE AND UNLAWFUL BODILY INJURY ON THE VICTIM OR ANOTHER PERSON



#### MARITAL RAPE

- A KIND OF ACQUAINTANCE RAPE BY THE MOST INTIMATE OF ACQUAINTANCES — THE SPOUSE
  - ROUGHLY 40% OF IPV SURVIVORS DISCLOSE SEXUAL ABUSE BY THEIR PARTNERS
- HISTORICALLY, NOT CONSIDERED A CRIME; NOW A CRIME IN ALL 50 STATES



#### MARITAL RAPE

- MOST LIKELY TO ENCOUNTER THIS TYPE OF RAPE WHEN THE SURVIVOR IS IN THE PROCESS OF LEAVING THE ABUSIVE RELATIONSHIP
- MAY BE RELUCTANT TO REPORT
- MORE LIKELY TO BE RAPED MULTIPLE TIMES AND SUFFER LONG-LASTING PHYSICAL AND PSYCHOLOGICAL INJURIES



#### **FAMILY STATISTICS**

OHOMES WITH ONLY ONE BIOLOGICAL PARENT→
CHILDREN WERE AT 2X THE RISK OF
SEXUAL ASSAULT

OCHILDREN LIVING WITHOUT BOTH BIOLOGICAL PARENTS → WERE AT 3X THE RISK OF SEXUAL VICTIMIZATION

OPRESENCE OF A STEPFATHER IN THE HOME **DOUBLED** THE RISK OF SEXUAL VICTIMIZATION FOR GIRLS.




#### **BARRIERS TO REPORTING**

- 1 DISTRUST/DISCONNECT FROM AUTHORITIES, GOVERNMENT, AND/OR INSTITUTIONS
- (2) LIMITS TO ACCESSING SERVICES
- 3 INTERNALIZATION OF BLAME (WHICH ALSO HAS CULTURAL IMPLICATIONS), SEXUAL VIOLENCE TOLERATED AS SOCIO-NORM
- 4 Conscious self-sacrificing for what is perceived as greater good
- (5) BELIEVABILITY AND LACK OF SOCIAL CREDIBILITY

# Sexual Exploitation

- Recruiting, harboring transporting, providing, or obtaining a person for commercial sexual acts including by force, fraud, or coercion.
- When the person induced to commit such acts is less than 18 years of age, it is not necessary to show force, fraud, or coercion.

# Labor Exploitation

 Recruiting, harboring transporting, providing, or obtaining a person by force, fraud, or coercion for the purpose of subjection to involuntary servitude, peonage, debt bondage, or slavery.

#### REALITIES OF TRAFFICKING

- TRAFFICKING VICTIMS DON'T HAVE TO BE BORN ABROAD
- TRAVEL, TRANSPORTATION, OR MOVEMENT ACROSS A STATE
   OR NATIONAL BORDER IS NOT NECESSARY
- HUMAN TRAFFICKING ISN'T ONLY CROSSING A BORDER.
   HUMAN TRAFFICKING INVOLVES COMMERCIAL SEXUAL ACTS
   OR LABOR, INDUCED BY FORCE, FRAUD, OR COERCION FOR
   THE PURPOSES OF INVOLUNTARY SERVITUDE OR SLAVERY
- PHYSICAL RESTRAINTS ARE NOT NECESSARY; CONTROL CAN BE PSYCHOLOGICAL, LIKE THREATS TO HARM THE PERSON OR THEIR FAMILY, OR DEPORTATION THREATS
- EVEN IF A VICTIM CONSENTED PRIOR TO ABUSE OR WAS PAID, IT CAN STILL BE TRAFFICKING



# **VICTIMS OF CRIME RIGHTS**

ALL MARSY'S LAW PROVISIONS APPLY WHERE APPLICABLE § 679.08 – NOTIFICATION OF VICTIMS' RIGHTS (VICTIM'S RIGHTS CARD)

- (A) (1) Whenever there has been a crime committed against a victim, the law enforcement officer assigned to the case may provide the victim of the crime with a "Victim's Rights Card," as specified in subdivision (B).
- Marsy's Law significantly expands the rights of victims in California. Under Marsy's Law, the California Constitution article I, § 28, section (B) now provides victims with the following enumerated rights:
- TO BE TREATED WITH FAIRNESS AND RESPECT FOR HIS OR HER PRIVACY AND DIGNITY, AND TO BE FREE FROM INTIMIDATION, HARASSMENT, AND ABUSE, THROUGHOUT THE CRIMINAL OR JUVENILE JUSTICE PROCESS.
- TO BE REASONABLY PROTECTED FROM THE DEFENDANT AND PERSONS ACTING ON BEHALF OF THE DEFENDANT.
- TO HAVE THE SAFETY OF THE VICTIM AND THE VICTIM'S FAMILY CONSIDERED IN FIXING THE AMOUNT OF BAIL AND RELEASE CONDITIONS FOR THE DEFENDANT.
- TO PREVENT THE DISCLOSURE OF CONFIDENTIAL INFORMATION OR RECORDS TO THE DEFENDANT, THE DEFENDANT'S ATTORNEY, OR ANY OTHER PERSON ACTING ON BEHALF OF THE DEFENDANT, WHICH COULD BE USED TO LOCATE OR HARASS THE VICTIM OR THE VICTIM'S FAMILY OR WHICH DISCLOSE CONFIDENTIAL COMMUNICATIONS MADE IN THE COURSE OF MEDICAL OR COUNSELING TREATMENT, OR WHICH ARE OTHERWISE PRIVILEGED OR CONFIDENTIAL BY LAW.



# MARSY'S LAW, CONTINUED

- TO REFUSE AN INTERVIEW, DEPOSITION, OR DISCOVERY REQUEST BY THE
   THE DEFENDANT'S ATTORNEY, OR ANY OTHER PERSON ACTING ON
   BEHALF OF
   THE DEFENDANT, AND TO SET REASONABLE CONDITIONS ON THE CONDUCT OF ANY SUCH INTERVIEW TO WHICH THE VICTIM CONSENTS.
- O TO REASONABLE NOTICE OF AND TO REASONABLY CONFER WITH THE PROSECUTING AGENCY, **UPON REQUEST**, REGARDING, THE ARREST OF THE DEFENDANT IF KNOWN BY THE PROSECUTOR, THE CHARGES FILED, THE DETERMINATION WHETHER TO EXTRADITE THE DEFENDANT, AND, **UPON REQUEST**, TO BE NOTIFIED OF AND INFORMED BEFORE ANY PRETRIAL DISPOSITION OF THE CASE.
- O TO REASONABLE NOTICE OF ALL PUBLIC PROCEEDINGS, INCLUDING DELINQUENCY PROCEEDINGS, **UPON REQUEST**, AT WHICH THE DEFENDANT AND THE PROSECUTOR ARE ENTITLED TO BE PRESENT AND OF ALL PAROLE OR OTHER POST-CONVICTION RELEASE PROCEEDINGS, AND TO BE PRESENT AT ALL SUCH PROCEEDINGS.
- TO BE HEARD, UPON REQUEST, AT ANY PROCEEDING, INCLUDING ANY DELINQUENCY PROCEEDING, INVOLVING A POST-ARREST RELEASE DECISION, PLEA, SENTENCING, POST-CONVICTION RELEASE DECISION, OR ANY PROCEEDING IN WHICH A RIGHT OF THE VICTIM IS AT ISSUE.
- TO A SPEEDY TRIAL AND A PROMPT AND FINAL CONCLUSION OF THE CASE AND ANY RELATED POST-JUDGMENT PROCEEDINGS.
- TO PROVIDE INFORMATION TO A PROBATION DEPARTMENT OFFICIAL CONDUCTING A PRE-SENTENCE INVESTIGATION CONCERNING THE IMPACT OF THE OFFENSE ON THE VICTIM AND THE VICTIM'S FAMILY AND ANY SENTENCING RECOMMENDATIONS BEFORE THE SENTENCING OF THE DEFENDANT



# **MARSY'S LAW CONTINUED**

- TO RECEIVE, UPON REQUEST, THE PRE-SENTENCE REPORT WHEN AVAILABLE TO THE DEFENDANT, EXCEPT FOR THOSE PORTIONS MADE CONFIDENTIAL BY LAW.
- TO BE INFORMED, UPON REQUEST, OF THE CONVICTION, SENTENCE, PLACE AND TIME OF INCARCERATION, OR OTHER DISPOSITION OF THE DEFENDANT, THE SCHEDULED RELEASE DATE OF THE DEFENDANT, AND THE RELEASE OF OR THE ESCAPE BY THE DEFENDANT FROM CUSTODY.
- TO RESTITUTION.
  - It is the unequivocal intention of the People of the State of California that all persons who suffer losses as a result of criminal activity shall have the right to seek and secure restitution from the persons convicted of the crimes causing the losses they suffer.
  - RESTITUTION SHALL BE ORDERED FROM THE CONVICTED WRONGDOER IN EVERY CASE, REGARDLESS OF THE SENTENCE OR DISPOSITION IMPOSED, IN WHICH A CRIME VICTIM SUFFERS A LOSS.
  - ALL MONETARY PAYMENTS, MONIES, AND PROPERTY COLLECTED FROM ANY PERSON WHO
    HAS BEEN ORDERED TO MAKE RESTITUTION SHALL BE FIRST APPLIED TO PAY THE AMOUNTS
    ORDERED AS RESTITUTION TO THE VICTIM.
- TO THE PROMPT RETURN OF PROPERTY WHEN NO LONGER NEEDED AS EVIDENCE.
- O TO BE INFORMED OF ALL PAROLE PROCEDURES, TO PARTICIPATE IN THE PAROLE PROCESS, TO PROVIDE INFORMATION TO THE PAROLE AUTHORITY TO BE CONSIDERED BEFORE THE PAROLE OF THE OFFENDER, AND TO BE NOTIFIED, **UPON REQUEST**, OF THE PAROLE OR OTHER RELEASE OF THE OFFENDER.
- TO HAVE THE SAFETY OF THE VICTIM, THE VICTIM'S FAMILY, AND THE GENERAL PUBLIC CONSIDERED BEFORE ANY PAROLE OR OTHER POST-JUDGMENT RELEASE DECISION IS MADE.
- TO BE INFORMED OF THE RIGHTS ENUMERATED IN PARAGRAPHS (1) THROUGH (16).



# **IPV** SURVIVOR RIGHTS

- CALIFORNIA PENAL CODE § 679.05 RIGHT TO HAVE DOMESTIC VIOLENCE OR ABUSE COUNSELORS PRESENT AT INTERVIEWS WITH LAW ENFORCEMENT AUTHORITIES; NOTICE
- (A) A VICTIM OF DOMESTIC VIOLENCE OR ABUSE, AS DEFINED IN SECTION 6203 OR 6211 OF THE FAMILY CODE, OR SECTION 13700 OF THIS CODE, HAS THE RIGHT TO HAVE A DOMESTIC VIOLENCE COUNSELOR AND A SUPPORT PERSON OF THE VICTIM'S CHOOSING PRESENT AT ANY INTERVIEW BY LAW ENFORCEMENT AUTHORITIES, DISTRICT ATTORNEYS, OR DEFENSE ATTORNEYS. HOWEVER, THE SUPPORT PERSON MAY BE EXCLUDED FROM AN INTERVIEW BY LAW ENFORCEMENT OR THE DISTRICT ATTORNEY IF THE LAW ENFORCEMENT AUTHORITY OR THE DISTRICT ATTORNEY DETERMINES THAT THE PRESENCE OF THAT INDIVIDUAL WOULD BE DETRIMENTAL TO THE PURPOSE OF THE INTERVIEW. AS USED IN THIS SECTION, "DOMESTIC VIOLENCE COUNSELOR" IS DEFINED IN SECTION 1037.1 OF THE EVIDENCE CODE. PRIOR TO BEING PRESENT AT ANY INTERVIEW CONDUCTED BY LAW ENFORCEMENT AUTHORITIES, PROSECUTORS, OR DEFENSE ATTORNEYS, A DOMESTIC VIOLENCE ADVOCATE SHALL ADVISE THE VICTIM OF ANY APPLICABLE LIMITATIONS ON THE CONFIDENTIALITY OF COMMUNICATIONS BETWEEN THE VICTIM AND THE DOMESTIC VIOLENCE ADVOCATE.



# PROTECTIONS/SUPPORT FOR IPV SURVIVORS, CONTINUED

FAMILY CODE SECTION 6303

- SUPPORT DURING COURT HEARINGS
- (A) IT IS THE FUNCTION OF A SUPPORT PERSON TO PROVIDE MORAL AND EMOTIONAL SUPPORT FOR A PERSON WHO ALLEGES TO BE A VICTIM OF DOMESTIC VIOLENCE. THE PERSON WHO ALLEGES TO BE A VICTIM OF DOMESTIC VIOLENCE MAY SELECT ANY INDIVIDUAL TO ACT AS A SUPPORT PERSON. NO CERTIFICATION, TRAINING, OR OTHER SPECIAL QUALIFICATION IS REQUIRED FOR AN INDIVIDUAL TO ACT AS A SUPPORT PERSON. THE SUPPORT PERSON SHALL ASSIST THE PERSON IN FEELING MORE CONFIDENT THAT THE PERSON WILL NOT BE INJURED OR THREATENED BY THE OTHER PARTY DURING THE PROCEEDINGS WHERE THE PERSON AND THE OTHER PARTY MUST BE PRESENT IN CLOSE PROXIMITY. THE SUPPORT PERSON IS NOT PRESENT AS A LEGAL ADVISER AND SHALL NOT GIVE LEGAL ADVICE.
- (B) A SUPPORT PERSON SHALL BE PERMITTED TO ACCOMPANY EITHER PARTY TO ANY PROCEEDING TO OBTAIN A PROTECTIVE ORDER, AS DEFINED IN SECTION 6218. WHERE THE PARTY IS NOT REPRESENTED BY AN ATTORNEY, THE SUPPORT PERSON MAY SIT WITH THE PARTY AT THE TABLE THAT IS GENERALLY RESERVED FOR THE PARTY AND THE PARTY'S ATTORNEY.

# YOUR RIGHTS as a Survivor of Sexual Assault

You have the right to get answers, the right to information, and the right to know. This card explains your rights, options, and helpful resources available to you under California Law (Penal Code 680, 2).

#### You Decide

It's your choice to:

- Get a physical exam
- Be part of a criminal case, or
- · Report the assault

No matter what you choose, you keep your rights.

A law enforcement officer or medical provider must provide you with a card that clearly spells out your rights.

- O PENAL CODE #679.04 GIVE VICTIMS OF SA OR SPOUSAL RAPE THE RIGHT TO HAVE AN ADVOCATE PRESENT AT ANY EVIDENTIARY MEDICAL, PHYSICAL EXAM, INTERVIEW BY LAW ENFORCEMENT, OR DISTRICT ATTORNEYS
- PENAL CODE #264.2

  REQUIRES LAW ENFORCEMENT
  OFFICERS TO IMMEDIATELY
  NOTIFY LOCAL RAPE CRISIS
  CENTERS WHEN VICTIM
  TRANSPORTED TO HOSPITAL
  FOR ANY MEDICAL EVIDENTIARY
  OR PHYSICAL EXAM

- Request sex offender registry information
- SEEK FINANCIAL ASSISTANCE FROM CALVCB
- HAVE A CONFIDENTIAL SA COUNSELOR AND A SUPPORT PERSON OF VICTIM'S CHOICE DURING EXAM OR INTERVIEW
- REQUEST IN WRITING AND RECEIVE FREE COPY OF INITIAL CRIME REPORT
- ASK THE STATUS AND RESULTS OF TESTING OF ALL EVIDENCE RELATED TO ASSAULT
- ANONYMOUS SART EXAM

# WHY TALK TO CLIENTS ABOUT TRAFFICKING?

VICTIMS OF LABOR TRAFFICKING ARE ENTITLED TO CERTAIN BENEFITS. THE PURPOSE OF ESTABLISHING WHETHER OR NOT CLIENT IS A LABOR TRAFFICKING VICTIM IS TO DETERMINE HER/HIS RIGHTS AND CONNECT THEM TO:

- STATE/FEDERAL SOCIAL SERVICE BENEFITS
- Immigration Relief (U visa, T Visa, Continued Presence) Civil Restitution (wage theft, compensation for damages)
- PROTECTION
- MEDICAL ASSISTANCE
- RESOURCES



# WHY TALK TO CLIENTS ABOUT HT?

Seldom will a client/potential client identify as a trafficking victim. It is imperative that advocates remain aware of the possibility that their client may have been trafficked. Advocates should talk to their clients about human trafficking when they perceive that victimization includes elements of:

- \* Force
- \* Fraud
- \* Coercion

# WHAT DO ALL THESE TERMS MEAN??!

- TRAUMA-INFORMED CARE IS AN APPROACH TO ENGAGING PEOPLE WITH HISTORIES OF TRAUMA THAT RECOGNIZES THE PRESENCE OF TRAUMA SYMPTOMS AND ACKNOWLEDGES THE ROLE THAT TRAUMA HAS PLAYED IN THEIR LIVES. -NATIONAL CENTER FOR TRAUMA INFORMED CARE (NCTIC, WWW.SAMSHA.GOV/NCTIC, 2013)
- VICTIM-CENTERED -THE PROVISION OF CULTURALLY APPROPRIATE AND IMMEDIATELY AVAILABLE SERVICES BASED ON THE UNIQUE NEEDS AND CIRCUMSTANCES OF VICTIMS AND SURVIVORS. SERVICES ARE SPECIFIC, CLIENT-FOCUSED AND DRIVEN BY THE INDIVIDUALS IMPACTED BY THE ABUSE/ASSAULT/EXPLOITATION. Washington Coalition of Sexual Assault Programs
- AN **EMPOWERMENT -BASED** PHILOSOPHY MEANS THAT WE BELIEVE THAT SURVIVORS OF ABUSE/EXPLOITATION ARE COMPETENT AND SHOULD HAVE THE FREEDOM TO BE INDEPENDENT.
- OUR CLIENTS HAVE JUST COME FROM A SITUATION WHERE THEY WERE CONTROLLED. IT IS NOT OUR JOB TO REPLACE ONE FORM OF CONTROL WITH ANOTHER. IT IS NOT OUR JOB TO TEACH THEM OR MANAGE THEM.
- EMPOWERMENT MEANS FOCUSING ON CLIENTS' STRENGTHS AND BELIEVING THAT THEY CAN MAKE A DIFFERENCE. EMPOWERMENT MEANS NEVER JUDGING CLIENTS' DECISIONS AND NEVER MAKING THEM FEEL LIKE THEY NEED TO HIDE THINGS FROM US — INCLUDING CONTACT WITH THEIR ABUSERS OR SUBSTANCE ABUSE.



### ADVOCACY EMPOWERMENT WHEEL

#### RESPECT CONFIDENTIALITY:

All discussions must occur in private, without other family members present. This is essential in building trust and ensuring her safety.

#### PROMOTE ACCESS TO COMMUNITY SERVICES:

Know the resources in your community. Is there a hotline and shelter for battered women?

#### HELP HER PLAN FOR FUTURE SAFETY:

What has she tried in the past to keep herself safe? Is it working? Does she have a place to go if she needs to escape?





# WHY SCREEN FOR INTERSECTIONS?

- Ensure that providers address different forms and intersections of violence and trauma
- ENSURE THAT SURVIVORS CAN EXPLORE ALL POSSIBLE PROTECTIONS, LEGAL REMEDIES, AND SOCIAL BENEFITS AVAILABLE TO THEM
- CONNECT SURVIVORS TO OTHER SERVICES AND PROGRAMS BASED ON THE SURVIVOR'S INDIVIDUAL NEEDS AND ELIGIBILITY (E.G. HOUSING, VOCATIONAL TRAINING PROGRAMS, SA ADVOCATES)
- CONNECT SURVIVORS TO LEGAL SERVICE PROVIDERS BASED ON SURVIVOR'S INDIVIDUAL SITUATION (E.G. IMMIGRATION, FAMILY LAW, EMPLOYMENT LAW, HOUSING, SOCIAL SERVICE BENEFITS)



# VICTIM NEEDS SCREENING TOOL

- SOUTH BAY COALITION TO END HUMAN TRAFFICKING SPENT TWO YEARS DEVELOPING A TOOL THAT IDENTIFIES POTENTIAL IPV/SA/HT
- Tool was launched with a training in 2016
- CS COLLECTED 97 SURVEYS FROM JUNE 2018 TO FEBRUARY 2019
- AACI, CS, AND YWCA COMMITTED TO COMPLETING THE TOOL WITH OPEN CLIENTS OVER 18 YEARS OLD

# REFERRAL PROCESS HT

THE *POINT AGENCY* SYSTEM IS ACTIVATED FOR ONE OF THREE PURPOSES:

- (1) TO ENSURE A ONE-HOUR ADVOCATE IN-PERSON RESPONSE FOLLOWING THE IDENTIFICATION OF A POTENTIAL VICTIM(S) BY A GOVERNMENTAL OR COMMUNITY BASED ORGANIZATION;
- (2) When a potential human trafficking victim is in immediate need of shelter, food, transportation, or accompaniment; or
- (3) WHEN A GOVERNMENTAL OR COMMUNITY BASED ORGANIZATION HAS IDENTIFIED A POTENTIAL HUMAN TRAFFICKING VICTIM AND SAID VICTIM HAS AGREED TO NON-URGENT ADVOCACY/CASE MANAGEMENT SERVICES.
